### **Market Demonstration Assistant**

## **Position Summary:**

Eastern Market Corporation (EMC), the 501(c)(3) non-profit management and development organization of the Eastern Market, operates several food access and entrepreneur programs with the goal of engaging people in conversation about healthy food choices, teaching the community valuable kitchen skills, and assisting food businesses in getting started.

EMC seeks a candidate to serve under the direction of both the Detroit Kitchen Connect Coordinator and Head Chef. The Market Demonstration Assistant(s) (MDAs) are responsible for execution of demonstrations in the Sheds, the Eastern Market Community Kitchen and Red Truck Fresh Produce so that EMC will have consistent published events that will engage the community, create and or renew interest in the various markets and encourage continued engagement with long-time market supporters.

Duties include but not limited to: managing inventory of demonstration and kitchen equipment and cleaning supplies; outreach to fill demonstration times with bona-fide and interesting activities; program scheduling; instruction of demonstration providers on temporary food licenses from the Detroit Health Department and food sampling guidelines (MDARD); proper and safe use of kitchen equipment; enforcement of sanitary food handling methods and kitchen use policies and procedures.

The MDAs will coordinate demonstrations in the market from April – December for Tuesday, Saturday, Sunday Street Market and Holiday Markets. Most events will run from 10am – 2pm in specified locations. MDAs are expected to be on premises from 7am to 4pm or until demonstration site has been closed and the kitchen and or facilities are clean.

#### **Responsibilities:**

- Ensure all demonstration participants are in compliance with Detroit Health Department licenses, all kitchen use policies and procedures and maintain relevant records to meet all federal, state, and local codes
- Recruit and schedule all demonstrations from May through December for the Eastern
  Market Sheds & EMCK from local restaurants, organizations, hospitals, and chefs to present
  demonstrations, tastings, informative nutritional classes, and tastings
- Develop marketing campaign with DKC program coordinator, Kitchen Manager and EMC Marketing team
- Track the number of participants at all events
- Develop survey to determine participant interest in topic, relevance, etc.
- Validate ServSafe certification and review proper food safety and sanitation practices
- Assist with one-on-one and group technical assistance for program participants
- Prepare recipes for demonstrations and Tasting Stations with direction from Head Chef
- Present cooking or nutritional demonstrations
- Other duties as assigned
